2	a) Examinee observed in possession and use of communication device / electronic gadget/ mobile phone / smart watch / tablet / I pad / earphone etc. during the examination	You will be booked for malpractice if you are again seen in possession of electronic device / gadget not permitted during the examination.	In case the examinee fails to comply even after being warned for more than 2 times under Malpractice Number-2, he/she shall be liable to a punishment of Cancellation of the performance of the examinee in that subject/course in the ongoing examination. 	b) Examinee observed in possession and referring to books, notes, web-sources or any other material or means to retrieve answers during the examination	You will be booked for malpractice if you are again seen in possession of book/notes/web sources not permitted during the examination.	
3	Additional person/s apart from the examinee is/are seen collaborating with examinee during the examination.	You will be booked for malpractice if you are again seen with additional person/s during the examination.	In case the examinee fails to comply even after being warned for more than 2 times under Malpractice Number-3, he/she shall be liable to a punishment of Cancellation of the performance of the examinee in all the subjects/courses for which he/she appeared in the current examination. Punishment Nomenclature: (1+0) (Applied on the Seat Number of the examinee.)
4	A person other than the designated examinee as shown in photograph on the hall ticket is seen attempting the examination.	You will be booked for serious malpractice of impersonation in the examination if person other than designated examinee is noticed on the screen again.	In case the examinee fails to comply even after being warned once, he/she shall be liable to a punishment of Cancellation of the performance of the examinee in all the subjects/courses for which he/she appeared simultaneously, as regular/ex-student in the current examination. Punishment Nomenclature: (1+0) (Applied on the enrollment Number of the examinee.)
